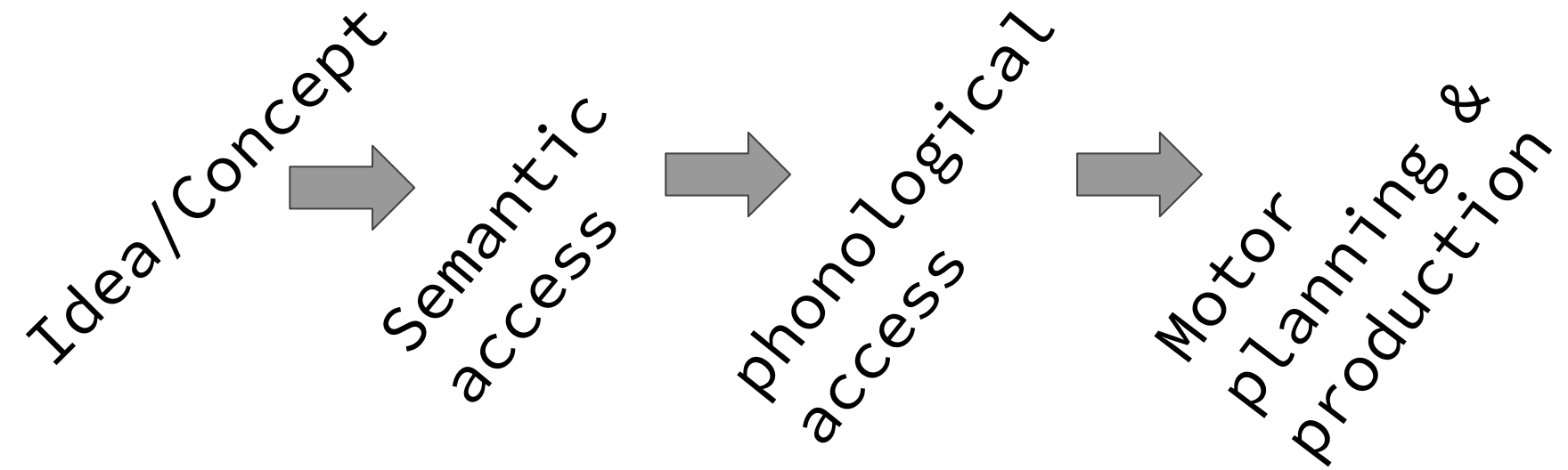

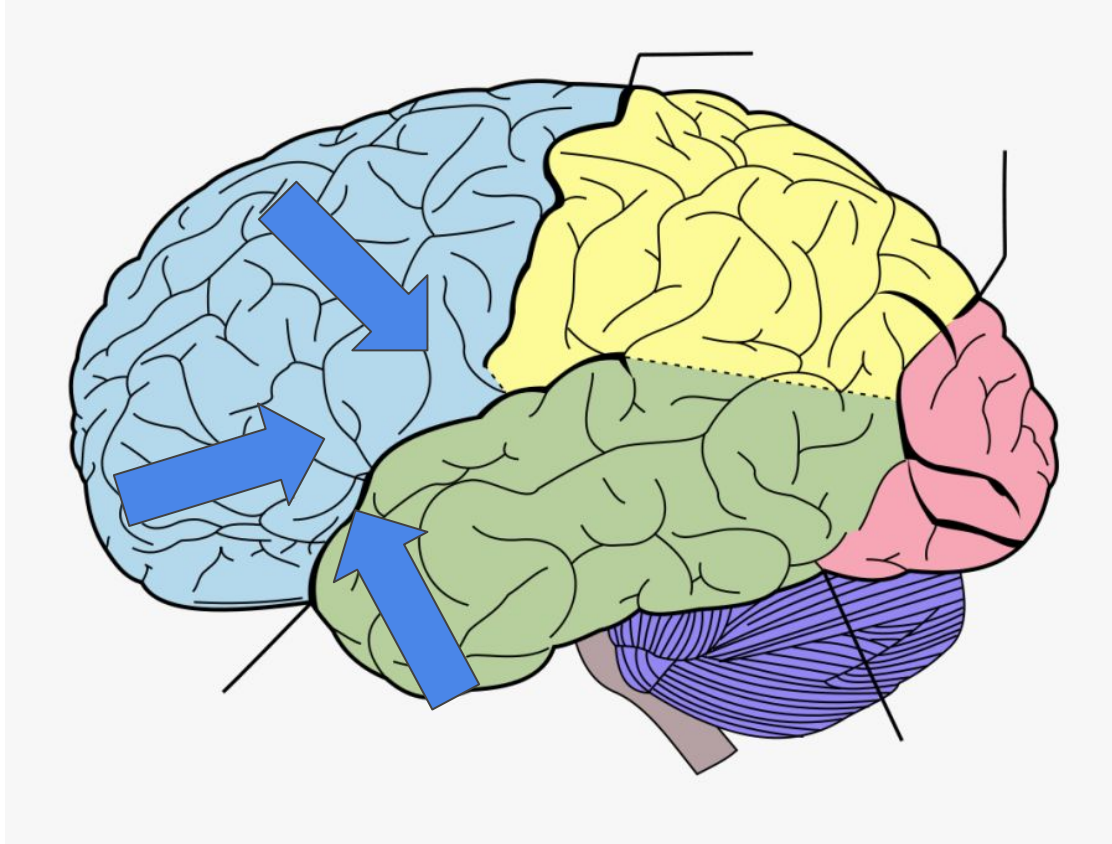

Assessment

Phonological Word Finding deficits

- Picture naming
- Oral word reading
- Repetition tasks
- Phonemic errors in speech or use of non-words in speech tasks

Semantic Word Finding deficits

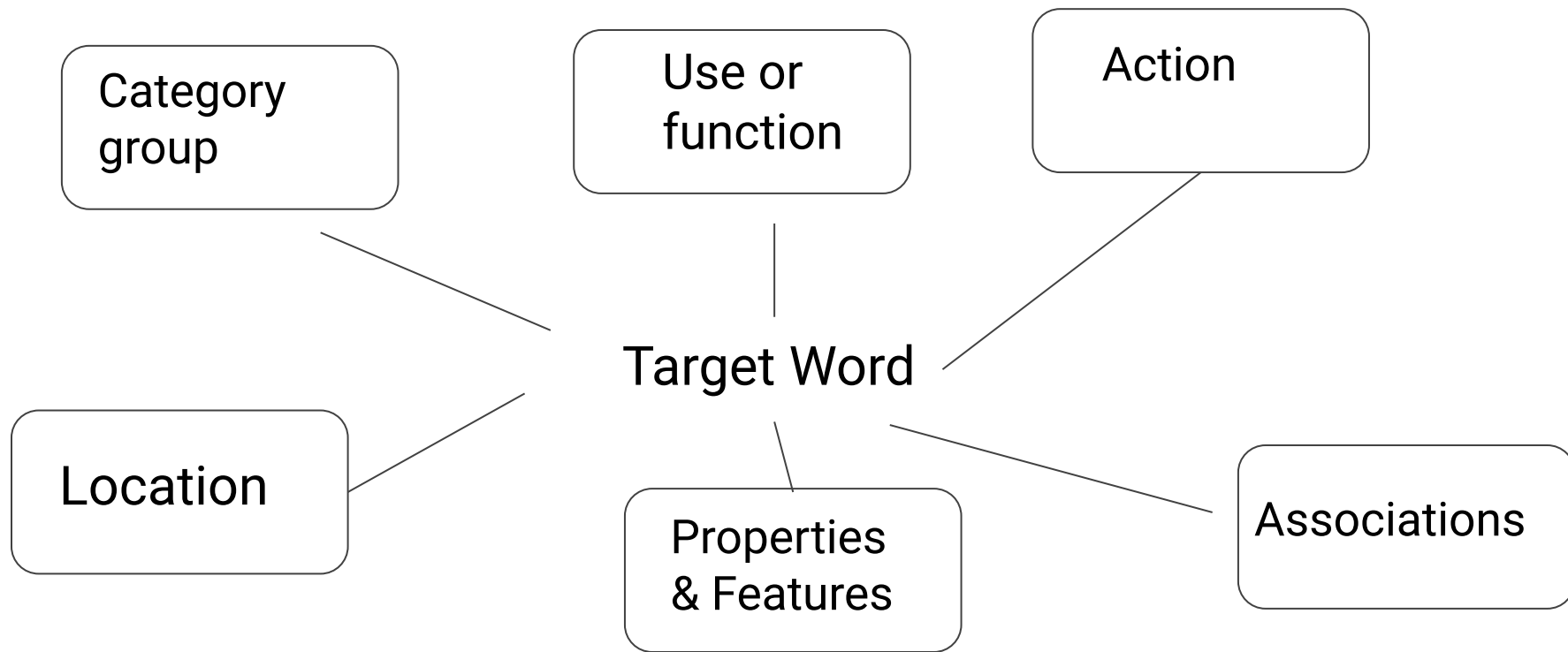
- Sorting objects by category
- Providing definitions for words
- Semantic association tasks
- Naming of an item within the same category as target word
- Naming a word associated to target word
- Use of circumlocution

Assessment

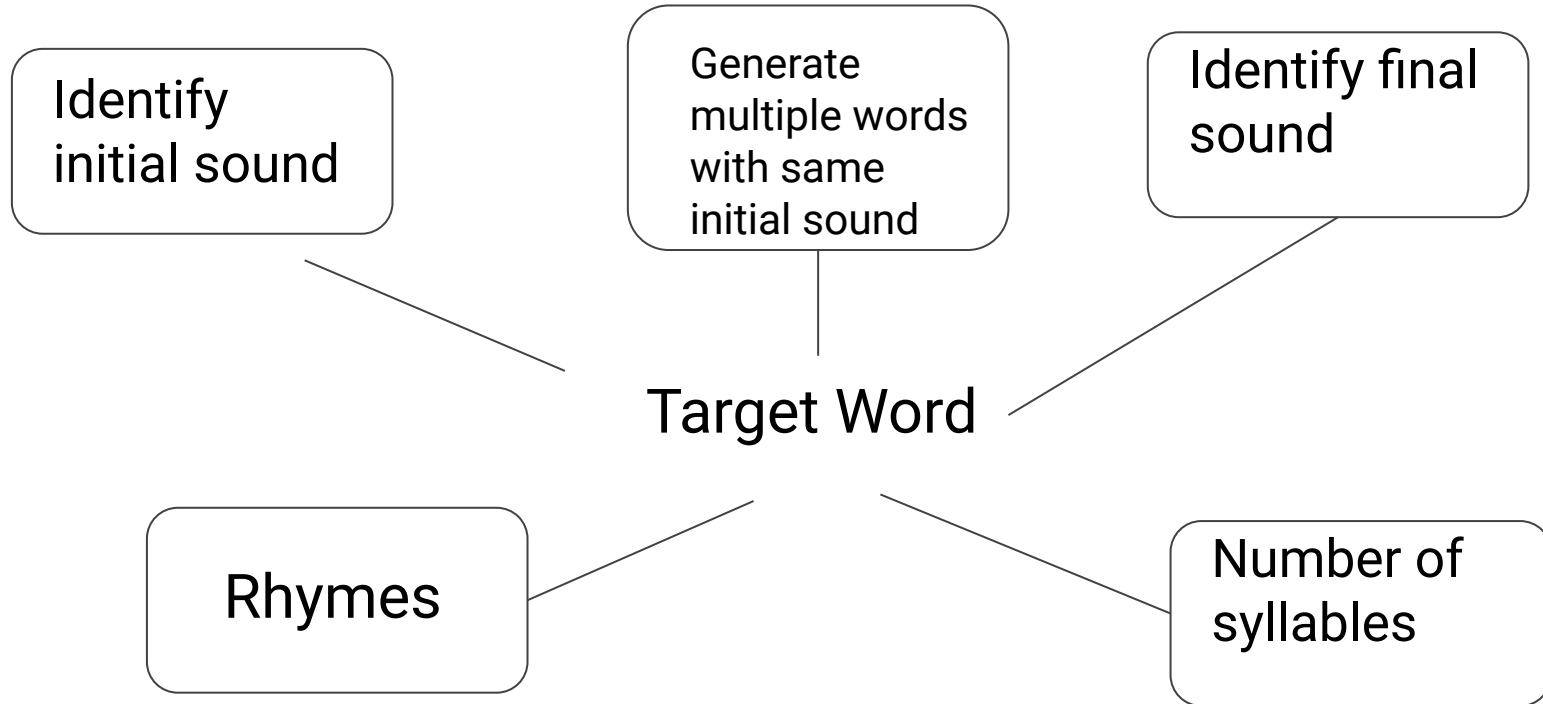
- Interview
 - Patient's daily activities
 - Hobbies and interests
 - Patient's own goals for communication or problems they notice in daily communication
 - Family and/or caregiver goals for communication or problems they notice in daily communication
